The basic type of engineering controls are: Process controls which involve changing the way a job activity or process is done to reduce the risk.
Appropriate engineering controls	Enclosure and/or isolation of emission source which keeps a selected hazard "physically" away from the worker and ventilation that strategically "adds" and "removes" air in the work environment.
